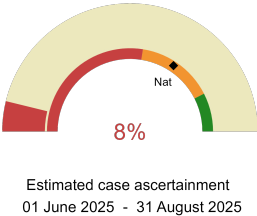

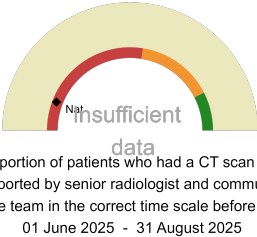
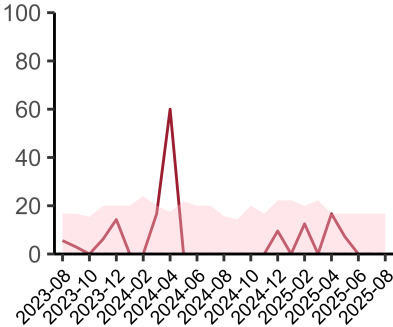
These plots represent patients having an emergency laparotomy during Year 2025-26 Reporting Period 5 of NELA data collection.

NELA process and outcome measures



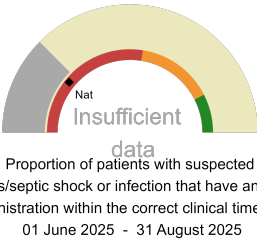
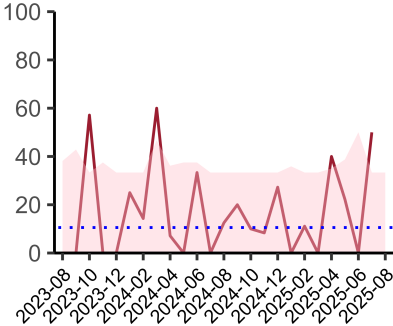

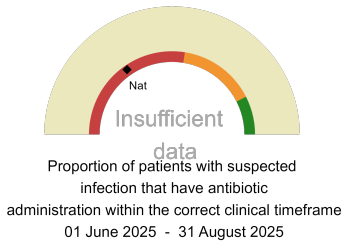
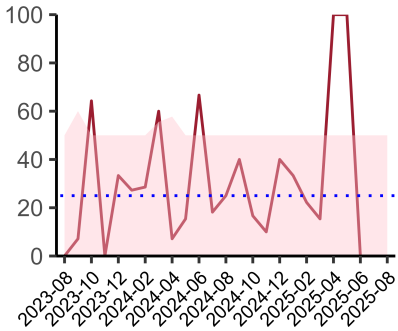
Combined Infection management standard - antibiotic administration within the correct clinical timeframe

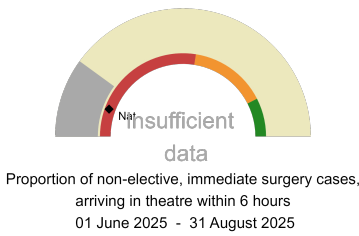

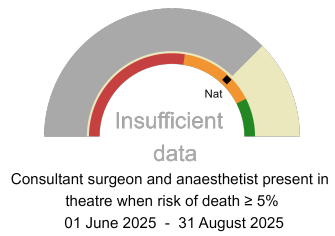

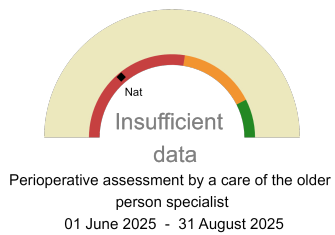

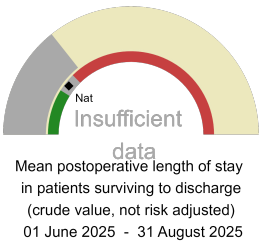

Median postoperative Length of Stay

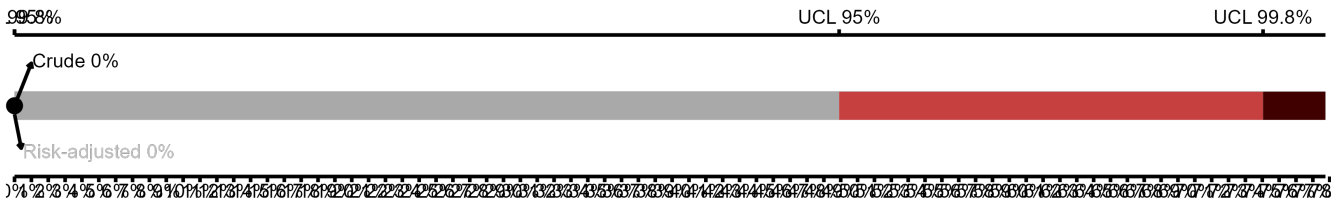
